The Goshen Central School District plans to use ARP ESSER funds purchase services for the purpose of upgrading and/or replacing airhandling and filtration equipment throughout the District, including unit ventilators, heating and/or cooling units.

Students in grades K-8 will be monitored through the use of NWEA MAPs assessments. Baseline measures will be acquired during the first 30 days of school. Students' RIT (Rasch Unit) scores will be analyzed and compared to previous year's scores. Additionally, student growth will be monitored as individual scores are compared to student norms as documented by NWEA. Targeted interventions may then be planned for and implemented. Students in grades 9-12 will be monitored through the use of STAR reading and math assessments (Renaissance Learning). These computer adaptive tests will provide information regarding students' current level of achievement, and in time, growth measures. Again, information gathered will allow classroom teachers and interventioists to design and implement targeted instruction/lessons to remediate known or newly discovered deficiencies.

The Goshen Central School District plans to implement a "Gladiator Gains" program to address lost instructional time in prospective years following administration of benchmark assessments. The primary focus will be in the areas of ELA, math, and literacy/fluency skills. This enrichment program will allow students to have an extended learning experience while working with New York State certified teachers in a fun, interactive, technology-rich, and safe learning environment. Students' performance on NWEA MAPs assessments, STAR assessments, Fountas and Pinnell Benchmark Assessments, and formative and summative classroom assessments will allow teachers to identify those in need of enrichment/intervention. The Gladiator Gains program will take place during the months of July and August.


